Service providers will then receive an NHS standard contract for completion and signature. The completed contract will need to be returned to the MLCSU Pharmacy Services team, Kingston House, 438 - 450 High Street, West Bromwich, B70 9LD.

Once accredited and when accessing the new Minor Ailments Service platform on PharmOutcomes (for the first time only), individual practitioners will need to enrol. Once the enrolment phase is complete, providers will be able to record details of MAS consultations.
